Using Direct Deposit is simple. When you file your tax return include your credit union account number in the designated spot and the credit union's routing and transit number, 272485136. Contact the credit union to verify your correct account number to ensure proper posting of your tax refund.

Your December statement will have all of your tax information on it. Don't wait around watching your mailbox for your check, choose direct deposit and get your cash twice as fast!
